Speaker Biographical Information (Brief version)

• **Dr. Robert Applebaum** is Professor of Gerontology in the Department of Sociology and Gerontology and Director of the Ohio Long-Term Care Project at the Scripps Gerontology Center, Miami University, Oxford, Ohio. He holds degrees from Ohio University (BA), the Ohio State University (MSW), and the University of Wisconsin-Madison (Ph.D.). He has been involved in the development and evaluation of long-term care programs across the United States for more than thirty years. He has worked with a number of states on innovations in long-term care service delivery, and completed a series of state and national studies on long-term care quality.

Dr. Applebaum has been a frequent speaker at national and state conferences on long-term care. He has authored more than 85 articles and monographs, and four books on long-term care.

Dr. Applebaum has been active in serving the Gerontological Society of America and the American Society on Aging. He has chaired the Social Research Planning and Practice Section of the Gerontological Society and has been a member of the Board of Directors of the American Society on Aging and Chair of the Editorial Board for the Society's journal, Generations.

- Nancy Tyler, J.D.M.S.W. holds a Masters in Social Work from West Virginia University and a Juris Doctorate from the University of Denver's School of Law. She is the former Counsel for the WV House of Delegates' Committee on Finance (2000-2007) and the Committee on Health & Human Resources (2007 - current), focusing on health issues. Ms. Tyler is a private healthcare consultant working in the Charleston area. Prior to July 1st of 2012, Nancy worked as Counsel for the House Health Committee for the West Virginia Legislature for five years and as Counsel for the House Finance Committee of the Legislature for seven years. She was primarily responsible for all health related bills for the Legislature. She also participated on a variety of committees as a liaison to the legislature. Ms. Tyler's background includes a variety of health related duties including the following: Director of the Office of Health Facilities Licensure and Certification in the Dept. of Health and Human Resources, Director of WV Operations for United Health Care, Deputy Attorney General, Executive Director of Boulder Valley Women's Health Center, Health Policy Analyst for the Sunrise/Sunset Committee of the CO Legislature and other positions in the health arena. She also has worked for United Cerebral Palsy, and Shawnee Hills Community Behavioral Health Center and has had a long term commitment to people with disabilities and enabling complete integration with the community. More recently she has provided consulting services to many organizations including the WV Partnership for Elder Living, the Perinatal Partnership, Cabin Creek Health Systems and the Center for Rural Health Development to name a few. She received her Bachelor of Arts in Family Services from Auburn University, her Masters in Social Work from West Virginia University and her Law Degree from the University of Denver.
- **Gaylene Miller** is the State Director of AARP-WV. Gaylene has worked in the field of aging programs and services for many years and is a tireless advocate on behalf of West Virginians 50 and over. She currently serves as the State Director for AARP in West Virginia.

A native West Virginian, Gaylene was educated in West Virginia public schools. She received her undergraduate degree from West Liberty State College and attended graduate school at West Virginia University.

Committed to community service, Gaylene is Past President of the Charleston Vandalia Rotary Club and the Alzheimer's Association - WV Chapter Board of Directors. She is also an active member of the Capitol Market Board of Directors.

Prior to coming to the AARP West Virginia State Office, she served as the Commissioner of the WV Bureau of Senior Services. Gaylene and her husband reside in the Charleston area. She is an avid West Virginia University Mountaineer fan and enjoys the great outdoors.

- Jane Marks retired in 2012 after 12 and 1/2 years as Executive Director of the Alzheimer's Association, WV Chapter. She is a published author of multiple journal articles on aging and Alzheimer's disease, as well creator of multiple training curriculum for both long-term care and in-home dementia care workers. She has worked as a technical writer for the National Clearinghouse on Aging, Social Gerontology Resource Center, was a professional development conference coordinator with the NASUA & N4A, and served as Executive Director at Marion County Senior Citizens, Inc. She established admissions counseling and unified care plan development at Montgomery Elderly Care, and was Assistant Director of the Area Agency on Aging, Region VI PDC.
